Budget Workshop

The City Council of Gilbertville, Iowa met in Regular Session Monday, February 6, 2023 at 6:00 p.m. Mayor Thome called the meeting to order. Council members present: Even, Frost, Perry, Brustkern and Becker. Quorum present.

Pledge of Allegiance

Janice Rosauer gave the invocation and Mayor Thome led the Pledge of Allegiance.

Approve Agenda

Motion by Becker, seconded by Frost to approve the February 6, 2023 regular session agenda. Ayes - Five. Motion carried.

Motion by Becker, seconded by Perry to approve following items listed on the consent agenda: 1) Minutes of the January 16, 2023 regular meeting; 2) Payment of bills, receipts and transfers; 3) Utility Billing Report January 2023. Ayes – Five. Motion carried.

Consent Agenda

Don Bosco eight grade students in Mrs. Zimmerman’s class Kloe Nissen, Addy Hyde, Izzy Phillips and Sydni Weber gave a presentation on a service project for feeding the hungry. They are proposing little food pantries in 3 location throughout the city. Motion by Becker, seconded by Brustkern to support the project and approve public works to make the pantries.

Mayor Thome opened the public hearing for water/sewer disconnects. Motion by Becker, seconded by Perry to close the public hearing. Roll call vote. Ayes – Five. Motion carried.

Water disconnect

Motion by Even, seconded by Frost to authorize the Public Works Department to disconnect the service and prior to reconnect, the resident will be required to pay the arrears and a \$50 reconnect fee. Ayes – Five. Motion carried.

Motion by Even, seconded Perry to approve Resolution 2023-02 granting certain financial assurances in conjunction with the Black Hawk County Gaming Association Grant Application. Roll call vote. Ayes – Five. Motion carried.
